Port of Entry Visa

Please bring the following when coming for visa application in person:

- Completed application form BI-84 in black ink
- 1 passport size colored photo (1.5"x2") taken against white background
- HK/Macao ID card & copy
- Passport & copy (bio-data page and HK/Macao visa/ permit page, if applicable) Please make sure passport should have minimum validity of 30 days counting from your intended departure from South Africa and it must have at least 2 blank visa pages
- Flight itinerary copy (return trip)
- Proof of accommodation in South Africa – Accommodation booking covering the whole journey/ Utility bill as address proof in South Africa (print out of certified true copy by South African authority is acceptable)
- Official Leave Letter from employer (for tourism) OR Guarantee Letter from employer (for business visit)
- Original or Certified True Copy of three months bank statement
- Invitation Letter **AND** Certified True Copy of inviter's S.A. ID/ passport/ foreign passport with valid S.A. permit (for tourism, if applicable) or Invitation Letter **AND** South African Business Registration copy (for business visit)
- ▷ Yellow fever vaccination card if your journey will entail through a yellow fever zone
- Cash payment of the non-refundable application fee of HK\$275, if applicable

For applicant under the age of 18, both parents have to be present at this mission to sign for consent for their child's visa application. Please also bring along child's full birth certificate (original and copy) as well as parents' passports (original and copy).

Domestic helper contract (original and copy) are required if domestic helper is applying for South African Visa.

*** Please note that additional documents may be required to support your application.
